I N D I C T M E N T

The Grand Jury charges: T H A T

JOSE JUAN MORENO-BELTRAN,
CARLOS CULEBRO, aka "UM76,"
RIGOBERTO RODRIGUEZ-VISCARRA, aka "UM159,"
LUIS ALBERTO RUBIO, aka "UM27," and
CRECENCIO LEON-CAMPUSANO, aka "TOCAYO,"

defendants herein, beginning at a time unknown to the Grand Jury,
but no later than on or about February 12, 2010, and continuing
to on or about March 6, 2010, in the Eastern and Central

Districts of California, and elsewhere, did knowingly and intentionally conspire with each other and with other persons known and unknown to the Grand Jury to possess with intent to distribute and distribute at least 500 grams of a mixture and substance containing a detectable amount of methamphetamine, a Schedule II controlled substance, in violation of Title 21, United States Code, Sections 846 and 841(a)(1).

FORFEITURE ALLEGATION: [21 U.S.C. § 853(a) - Criminal Forfeiture]

The Grand Jury further charges:

JOSE JUAN MORENO-BELTRAN,
CARLOS CULEBRO, aka "UM76,"
RIGOBERTO RODRIGUEZ-VISCARRA, aka "UM159,"
LUIS ALBERTO RUBIO, aka "UM27," and
CRECENCIO LEON-CAMPUSANO, aka "TOCAYO,"

defendants herein, as follows:

Upon conviction of the offense alleged in this Indictment defendants JOSE JUAN MORENO-BELTRAN, CARLOS CULEBRO, aka "UM76," RIGOBERTO RODRIGUEZ-VISCARRA, aka "UM159," LUIS ALBERTO RUBIO, aka "UM27," and CRECENCIO LEON-CAMPUSANO, aka "TOCAYO," shall forfeit to the United States pursuant to 21 U.S.C. § 853(a) the following property:

a. All right, title and interest in any and all property involved in each offense in violation of Title 21, United States Code, Section 841(a)(1), or conspiracy to commit such offense, for which defendant(s) is/are convicted, and all property traceable to such property, including the following: all real or personal property, which constitutes or is derived, directly or indirectly, from proceeds obtained as a result of the commission of the offense; and all property used in any manner or

1 part to commit or to facilitate the commission of this violation.


2 b. A sum of money equal to the total amount of money
3 involved in each offense, or conspiracy to commit such offense,
4 for which defendant(s) is/are convicted.

5 If any property subject to forfeiture, as a result of the
6 offense alleged in this Indictment cannot be located upon the
7 exercise of due diligence; has been transferred or sold, or
8 deposited with, a third party; has been placed beyond the
9 jurisdiction of the Court; has substantially diminished in value;
10 or has been commingled with other property which cannot be
11 subdivided without difficulty, it is the intent of the United
12 States, pursuant to Title 21, United States Code, Section 853(p),
13 to seek forfeiture of any other property of defendant(s) up to
14 the value of the property subject to forfeiture.
